NESMC (North East of Scotland Motorsport Club) has evolved from NESMG (North East of Scotland Motor Group) established 31st January 1974. The NESMC is made up of 6 car clubs in the area – Aberdeen & District MC, 63 Car Club, Stonehaven & District MC, Saltire Rally Club, 750 MC and Highland Car Club. Members of the 6 car clubs will automatically become members of the NESMC. It will not be possible to join NESMC without being a member of one of the six clubs. There is no cost to join NESMC this is covered by an annual subscription fee paid by each club. NESMC will not organise any events but will promote events organised by the individual clubs.

The NESMC will continue to build a strong connection between the six clubs. By forming a union between the clubs matters such as event dates, training events and resources can be discussed. The NESMC will also become a common communication point to distribute information from each individual club to all the clubs. Another main reason for forming a club is to allow a championship to be run. The championship will initially consist of Autotest and Navigational Rallies, by having the NESMC and the six clubs as invited clubs will allow people to compete on events using their club cards.

Observations from TV Coverage of Wales Rally GB

It was very encouraging to read in Motorsport News this week about the strong viewing figures for Wales Rally GB on Channel 5. However, I was reading this the morning after chairing our Association meeting at which we discussed the same TV coverage in response to a formal letter received from one of our member clubs.

As you well know from both your own visits to Scotland and no doubt from Safety Delegate feedback, the need for a greater focus on safety on stage rallies has been fully recognised, accepted and implemented conscientiously by organisers of events across Scotland since the new requirements were introduced last year.

Implementing Rally Future has created significant additional work and costs for organisers. There has also been a need for spectators to change their viewing habits, and restrictions on the media, not to mention the need for additional marshals and officials, who are also in scarce supply. Organising clubs in Scotland have gone to great lengths to comply with all aspects of the new requirements in order to play their part in protecting the future of Rallying in the UK.

In light of all this, it was both disappointing and concerning to witness on live television on Sunday 30 October on the final special stage of Wales Rally GB various apparent lapses in safety unworthy of the UK's premier stage rally. Further, anecdotal evidence, including pictures posted on social media, and other broadcast coverage suggests that this stage was not unique. Safety issues observed included:



- Spectators and marshals standing in what looked to be unsafe places at the stages edge.
- Vehicles apparently parked at much less than the required distance from the stage route.
- What appeared to be a blocked escape road.
- A photographer crouching on the inside of the final corner at the Flying Finish.
- Marshals taking photographs.

I would like to think that officials at the MSA have made the same observations and have begun an appropriate enquiry into the apparent safety lapses on this high profile event.

Local rally clubs look to their Governing Body to set standards to which they can aspire. The MSA member clubs organising stage rallies in Scotland would welcome some feedback as to how these lapses were permitted. The issue of primary concern to the SACC member clubs is that if spectators, the media and others view what they saw on television as acceptable practice in the UK then there is the potential for even greater pressure on organisers and marshals, and tensions between them and individuals attending their event in whatever capacity.

The people discussing this at the SACC meeting understand that the event ran to FIA regulations and standards but the concern expressed was that the general public seeing these images will not make that distinction.

Accordingly, we would like the MSA to make some comment on what was seen, perhaps in MSA Extra and other publications. In particular, to acknowledge the apparent shortcomings in meeting the Rally Future safety requirements and making it clear that some of the behaviour on WRGB fell short of what is expected. Perhaps the MSA could express regret that the highest standards to which we all aspire were not always maintained on the UK's flagship event showing there is still much work to be done. The upcoming MSA official's seminars would be another opportunity to do this.

I regret writing to you in these terms but having visited us as recently as September, I am sure you will understand the strength of feeling from our rally organising clubs.
